4.0 OVHLA Name: Does it represent our membership?

This item was an update from the discussion held at the September 30, 2008 meeting. The discussion focused on two issues: 1) whether the name of this chapter, Ottawa Valley Health Libraries Association / Association des bibliothèques de la santé de la Vallée d'Outaouais, accurately reflects the membership, and 2) whether the Kingston Chapter should be integrated into the Ottawa Valley Chapter.

The Kingston Chapter is currently inactive and Kingston representatives attend OVHLA functions when possible.

Following the September 30, 2008 meeting, Cathy MacLean contacted CHLA regarding the process for integrating the Kingston Chapter into the Ottawa Chapter. In summary, CHLA indicated, "the Board is fine with any decisions that you make regarding a merger of your two Chapters. What is required is clear documentation of your merger, and if you do merge prior to the 2010 Kingston Conference, any conference proceeds from Kingston must be allocated to the new Chapter, and of course as a Chapter, you would determine how you would later expend

those proceeds. It is very important to document the merger and proposed allocation of any conference proceedings.

In reviewing our CHLA/ABSC Executive Manual, I note that Article 7.3 states that:

"Chapters that wish to become inactive must notify CHLA/ABSC of their intention (this would also apply to your possible merger).

Chapter assets must be distributed appropriately (this would include any proceedings from Kingston 2010).

Financial records need to be retained for 7 years. These can be sent to the Association office by courier or registered mail."

Kingston members of CHLA are hosting the 2010 CHLA. It was decided that the issue of combining the chapters and/or renaming OVHLA would be brought forward following the 2010 CHLA conference. Since much of the initial planning for the 2010 Conference has already taken place, it is only fair that the Kingston members benefit from the potential profits of the conference.

6.0 Additional Agenda Items

6.1 Constitution and By-Laws, Article 4: Officers and Article 5: Elections

Upon review of Articles 4 and 5 Cathy MacLean noted a discrepancy between OVHLA practice and the written Constitution/By-Laws in regards to the following:

- 1. length of terms for officers
- 2. timing of elections
- 3. date for the Annual General Meeting

Upon discussion it was agreed that the following changes would be made:

- 1. Stagger the terms for officers to ensure continuity when officers change
 - 2. Change from one-year to two-year terms for officers
 - 3. Add the position of Continuing Education Officer
 - 4. Call for nominations over the summer of 2009 with the goal of finding replacements for two positions (Secretary and President) for the September 2009.
 - 5. For the positions of Secretary and President the next term will span from September 2009 to June 2011.
 - 6. For June 2010 new incumbents will be sought for the positions of Treasurer and Continuing Education Officer and these positions will be held from June 2010 to June 2012.
 - 7. The Annual General Meeting will be held in June of each year.

New wording to recognize the suggested changes will be brought forward in September 2009.

As a result of this discussion the group realized that the website is written in English only. Ginger Taylor volunteered to enquire about the possibility of translating website text.

7.0 Roundtable Discussion -- share news from your library

Items of note included the following...

Ginger Taylor thanked members for their letters of support for services at NRC-CISTI. She encouraged members to be as specific as possible when advocating for the services they feel are indispensable. NRC-CISTI would appreciate as much feedback as possible.

As mentioned above, Kingston area librarians are hosting the 2010 CHLA/ABSC conference. Representatives introduced the logo and theme for the conference to be held on June 7 to 11, 2010 in Kingston. Mahalya Havard noted that the Centre hospitalier Pierre-Janet in Hull is remodeling the library and updating the collection and will reopen in September 2009.
