Philip Allan at Canadian Forces is retiring in December 2009 after 33 years of service.

The opening of the Irving Greenberg Family Cancer Centre at the Queensway-Carleton Hospital, in partnership with The Ottawa Hospital Regional Cancer Program, will include the opening of a new consumer health library within the Cancer Centre. The library will be staffed by Library Services at the Ottawa Hospital and is scheduled to be opened in early 2010.

The Seniors Health Research Transfer Network (SHRTN) is at the end of a three-year funding cycle and funding is currently under review.

The University of Ottawa recently received a visit from the Association of Research Libraries (ARL) as part of the process for membership. In addition, in January 2010, the University of Ottawa will launch Endeca, a new interface for the library catalogue. In the near future, the University will be posting a librarian position in order to staff the library at Montfort Hospital.
